NOTICE INVITING E-TENDER FOR ELECTRICAL WORKS

Online item rate tender (E-tender) are hereby invited through e-tendering Portal https://etenders.gov.in/eprocure/app for the work of Round the clock Operation & minor maintenance of 2 x 5MVA, 66/11kV Substation, Transformer centers and their associated HT& LT Switchgears, Operation of DG Sets and various UPS systems and maintenance of laboratory building Electrical installations at CSIR-NAL, Kodihalli, Bengaluru-560 017 from approved & eligible vendors / contractors & who have worked with CSIR or its Laboratories / institutes, CPWD, Railways, MES, State / Central Govt. / Semi Govt. organizations / Public Sector undertaking / Govt. Autonomous bodies / KPTCL / BESCOM and all ESCOMS. The eligible bidders who having the Supergrade electrical license issued by Chief Electrical Inspectorate, Govt. of Karnataka to work on EHV electrical installation, proof of registration with GST, ESI & EPF authorities and satisfactory work completion certificate for at least three similar works each of value not less than 40% or two similar works each of value not less than 60% or one similar work of value not less than 80 % of estimated cost as shown in the NIT in CSIR or its Laboratories / CPWD / Railways / MES / State / Central Govt. / Semi Govt. organizations / Public Sector undertaking / Govt. Autonomous bodies / KPTCL / BESCOM / all ESCOMS during the last seven (7) years ending last day of the month previous to the one in which tenders are invited. The contractor / vendor / bidder fulfilling the above conditions may download the tender document https://etenders.gov.in/eprocure/app. The estimated cost of work put in the tender is based on Minimum wages prescribed by GoI and CPWD DSR 2025.

- a. <u>Similar works means:</u> Operation & maintenance of 66/11 kV & above rated EHV sub stations and its associated electrical equipment's.
- b. <u>Credentials:</u> Must have credentials (satisfactory work completion certificate) of similar jobs successfully carried out in the CSIR or its Laboratories / Institutes, CPWD, Railways, MES, State / Central Govt. / Semi Govt. organizations / Public Sector undertaking / Govt. Autonomous bodies / KPTCL / BESCOM / all ESCOMS during the last seven (7) years ending last day of the month previous to the one in which tenders are invited. The value of works shall be as follows:

Three completed works each costing ₹ 37.30 Lakhs (40% of the estimated cost) or above

Or

Two completed works each costing ₹ 55.95 Lakh (60% of the estimated cost) or above

Or

One completed work costing ₹ 74.60 Lakh (80% of the estimated cost) or above.

- c. **Statutory Requirements:** Should have (i) GST Registration, (ii) PAN, (iii) EPF and ESI registration certificate as stipulated in the tender document & (iv) Supergrade electrical license Certificate or equivalent Certificate issued by Chief Electrical Inspectorate, Govt. of Karnataka or Those who have Electrical incense to work on EHV installations issued by the govt. authorities other than Karnataka state. The vendors who have Electrical license from other than Karnataka state they have to submit Letter of undertaking for obtaining authentication with respect to Electrical License from the Chief Electrical Inspectorate, Govt.of Karnataka, Bengaluru as per the letter no. .CEA-PS-16/25-2023-CEI Division CEA (Ministry of power), Govt. of India notified under notification No. ENERGY 16 CORD 2025 dated 24.07.2025, Department of Energy, Govt. of Karnataka.
- d. **Electrical License:** The contractor shall have to submit the valid electrical license during applying of tender, issued from the Competent Authority in the name of the firm / contractor (under renewal application of electrical license will be not be considered).
