

6. Open Tender enquiry:

Only Local suppliers with prescribed local content as detailed in DPIIT Order No. P-45021/2/2017-PP (BE-II) dated 16th Sep, 2020 and subsequent orders issued by Ministry of Finance, Government of India from time to time, are eligible for bidding. bidders' must enclose the certificate declaring the local content of supplies as per the format.

7. Global Tender Enquiry:

Either the Indian Agent on behalf of the Foreign Principal or the Foreign Principal can bid directly in a tender but **not** both. However, the offer of the Indian Agent should also accompany the authorisation letter from their principal. To maintain sanctity of tendering system, one Indian Agent **cannot** represent **two** different foreign principals in one tender.

- (a) In case of agents quoting in offshore procurements, on behalf of their principal manufacturers, one agent cannot represent two manufacturers or quote on their behalf in a particular tender enquiry.

One manufacturer can also authorize only one agent/ dealer. There can be only one bid from the following:

i)	The Principal manufacturer directly or through one Indian agent on his behalf; and
ii)	Indian/foreign agent on behalf of only one principal.

- (b) Foreign bidders' must disclose the name and address of agent and representative in India and Indian bidders' must disclose their foreign principal or associates.


Machining of high temperature fiber reinforced composites top and bottom bypass duct as per the following supplied drawings and CAD models listed below in Table 1. 3D CAD models in STP/IGS format and 2D drawing in PDF format will be provided to the vendor awarded with PO. These parts are not isolated in nature and quote/bid price will be considered based on total cost and not individual item cost. However, vendor is requested to quote/quantity for each item (Serial No. mentioned in Table 1) separately.

COMPOSITE TOP SKIN WITH TOOL-TOP VIEW





Figure 1: Top view and side view of bypass duct top skin part with tool




Figure 2: Bypass duct top skin part with tool before machining




Figure 3: Bypass duct top skin part with tool after machining





Figure 4: Top skin bosses with respective identification numbers




Figure 5: Typical Cross section view of bypass duct top skin part before and after machining at X = 415




Figure 6: Typical Cross section view of bypass duct top skin part before and after machining at X = 457.3






Figure 7: Typical Cross section view of bypass duct top skin part flanges before and after machining




Figure 8: Top view and side view of bypass duct bottom skin part with tool




Figure 9: Bypass duct bottom skin part with tool before machining





Figure 10: Bypass duct bottom skin part with tool after machining






Figure 11: Bottom skin bosses with respective identification numbers




Figure 12: Typical Cross section view of bypass duct bottom skin part before and after machining at X = 713.03




Figure 13: Typical Cross section view of bypass duct bottom skin part before and after machining at X = 896.12




Figure 14: Typical Cross section view of bypass duct bottom skin part flanges before and after machining

2.1. General instructions

- i. These are general guidelines and vendor is whole responsible to adopt the process steps for machining of bosses to the drawing requirements.
- ii. Part along with tool will be supplied to vendor for machining. Vendor can adopt appropriate clamping method for securing part on tool. In such case part and tool should not get any damage.
- iii. Material for tool and part is SA 516 grade steel and carbon fiber reinforced thermosetting composite respectively.
- iv. Machining of the bosses & flanges in the part to final dimension as per the supplied drawing has to be done using OTP holes from the tool as reference.

- v. After boss machining, multiple cutout holes of different diameter have to be drilled on bosses mentioned in Sl. No. 1 to 11 of Table 2 & Sl. No. 1 to 29 of Table 3. Typical depth of cutout holes to be drilled is 70 to 80% of cutout hole depth given in CAD model.
- vi. Positional tolerance for individual cutout holes as compared to CAD model: +/-0.2 mm. Dimensional tolerance for all cutout holes is +0.25 mm & -0.05mm.
- vii. Flatness tolerance for all machined bosses and machined flange surface with respect to CAD model is +/-0.1mm.
- viii. Bosses and flanges to be machined to surface finish of 5 µm.
- ix. The inspections have to be carried out using OTP holes w.r.t CAD model for all bosses, blind holes and overall length of the duct. Vendor to carry out inspection using CMM / Laser scanning method for dimension, tolerance. Contact/Non-Contact Surface roughness tester for surface finish inspection. The CMM / Laser Scanning & Surface roughness tester equipment/s should be calibrated and should have required validity for period of inspection. A calibration certificate of the equipment used, to be submitted to NAL. A signed copy of CMM/ Laser inspection & Surface finish inspection report to be submitted to NAL. An individual report to be prepared for each quantity per items mentioned in Table 1.
- x. The step by step process sheet (Quality Assurance Plan) for machining to be submitted to NAL for record purpose.

5 Installation, Commissioning and Acceptance Test

The acceptance test will be conducted by the Purchaser, their consultant or other such person nominated by the Purchaser at its option after the equipment is installed at Purchaser's site in the presence of supplier's representatives. The acceptance will involve trouble free operation. There shall not be any additional charges for carrying out acceptance test. No malfunction, partial or complete failure of any part of the equipment is expected to occur. The Supplier shall maintain necessary log in respect of the result of the test to establish to the entire satisfaction of the Purchaser, the successful completion of the test specified.

On the event of the ordered item failing to pass the acceptance test, a period not exceeding two weeks will be given to rectify the defects and clear the acceptance test, failing which, the Purchaser reserve the right to get the equipment replaced by the Supplier at no extra cost to the Purchaser.

Successful conduct and conclusion of the acceptance test for the installed goods and equipment shall also be the responsibility and at the cost of the Supplier.

The acceptance tests plan (ATP) at the final destination (NAL) include the following:

- 5.1** Machined composite part should meet all the requirements mentioned in the 2D drawing/s.

The acceptance tests at the final destination (NAL) include the following:

- a) Machined bosses contour, machined flanges dimensional measurement, Blind holes' positions and its dimensional measurements checks and Inspection as per the supplied drawings. Deviations if any, to be corrected by vendor without any additional costs to NAL.
- b) Surface finish of machined bosses.

- 5.1.1.** If any deviation is found in boss contour, hole position and dimensional measurements, checks as per the supplied drawings after inspection, part will be rejected.

- 5.1.2.** After the machining, surface finish of the bosses to be as per the requirement.

6 Incidental Services

Mode of Dispatch of part secured on tool between CSIR -NAL and bidder location

CSIR-NAL will dispatch part mounted on tool to bidders' location for each quantity in a phased manner over a period of five months. After completion and acceptance of each quantity, part secured on tool for processing next quantity will be supplied to bidders.

Since this is part supply, part along with tool will be send to vendor's place as and when required. Initially both the part along with tool will be send to vendor's place. Subsequently as the part gets fabricated at CSIR-NAL, the part along with tool will be send to vendor for machining. Vendor is requested to send an invoice for each shipment separately. Separate payment will be made for each invoice after its acceptance as per section 5.1. Duration of the PO will be till June 2026.

NAL will arrange for transport of part secured on tool to bidder's place or other place where work will be done if it is less than 50 KM from CSIR-NAL Bangalore. Otherwise, Bidder has to take care of transport. Bidder needs to quote the transport charge separately for each transportation.

The bidder is required to upload, along with the bid, all relevant certificates such as BIS licence, type test certificate, approval certificates and other certificates as prescribed in the Product Specification given in the bid document.

23. **Generic**

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.
2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.
3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

24. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

25. **Generic**

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.

8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
15. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
16. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers/Service Providers shall ensure full compliance with all applicable labour laws, including the provisions, rules, schemes and guidelines under the four Labour Codes i.e. the Code on Wages, 2019; the Industrial Relations Code, 2020; the Occupational Safety, Health and Working Conditions Code, 2020; and the Code on Social Security, 2020 as and when notified and brought into force by the Government of India.

For all provisions of the Labour Codes that are pending operationalisation through rules, schemes or notifications, the corresponding provisions of the pre-existing labour enactments (such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972, etc. and relevant State Rules) shall continue to remain applicable.

The Seller/ Service Providers shall, therefore, be responsible for ensuring compliance under:

- **All notified and enforceable provisions of the new Labour Codes as mentioned hereinabove; and**
- **All operative provisions of the erstwhile Labour Laws until their complete substitution.**

All obligations relating to wages, social security, safety, working conditions, industrial relations etc. and any other statutory requirements shall be strictly met by the Seller/ Service Provider. Any non-compliance shall constitute a breach of the contract and shall entitle the Buyer to take appropriate action in accordance with the contract and applicable law.
