### GENERAL CONDITIONS:

1. The Period of training will be one year from the date of joining.
2. The training will be under the guidance of Superintendent, Apprenticeship Training ASDC, CSIR-NAL.
3. CSIR-NAL will not provide accommodation to the apprentice trainee and they should make their own arrangements.
4. The Director, CSIR-NAL will not be held responsible for any injury or risk that may be caused to the apprentice trainee while undergoing training in CSIR-NAL.
5. You will be granted 12 days casual leave; 15 days medical leave on production of medical certificate from Registered Medical Practitioner in a year. However, 10 days extraordinary leave without stipend will be granted only on emergency hospital grounds.
6. It shall be neither obligatory on the part of the employer to offer any employment to the Apprentice on completion of period of his/her Apprenticeship Training in this Establishment nor shall it be obligatory on the part of the Apprentice to accept an employment under the employer.
7. The admission of the above Apprentices are governed by the Apprentices Act, 1961 and any orders that may be issued from time to time by the Regional Directorate of Skill Development & Entrepreneurship (RDSDE), Ministry of Skill Development & Entrepreneurship, FTI Campus, Yeshwanthpur, Bengaluru, Karnataka – 560 022.
8. This admission is subject to production of all original certificates SSLC, ITI, Character, Conduct and Nativity certificate issued by the Principal of the Institution last attended, Medical certificate, Caste Certificate issued by the Competent Authorities.
9. The other terms and conditions of admission order and contract form will also equally apply.
