NOTICE INVITING E-TENDER FOR ELECTRICAL WORKS

Administrative officer invites the sealed item rate online tender (E-tender) on behalf of The Director, CSIR-NAL for the work of Replacement of existing air conditioners plant installed at Conference hall, ACD main building, CSIR – NAL, Kodihalli, Bengaluru – 560017 from approved & eligible vendors / contractors & who have worked with CSIR or its Laboratories / institutes, CPWD, Railways, MES, State / Central Govt. / Semi Govt. organizations / Public Sector undertaking / Govt. Autonomous bodies / KPTCL / BESCOM and all ESCOMS. The eligible bidder who having the Class - I electrical license or equivalent certificate issued by Chief Electrical Inspectorate authorities, Govt. of Karnataka / Govt. of India / any other state Govt. authorities to work on electrical installation or OEM / OEA of air-conditioner manufacturers, proof of registration with GST, ESI & EPF authorities and satisfactory work completion certificate for at least three similar works each of value not less than 40% or two similar works each of value not less than 60% or one similar work of value not less than 80 % of estimated cost as shown in the NIT during the last seven (7) years ending last day of the month previous to the one in which tenders are invited. The contractor / vendor / bidder fulfilling the above conditions may download the tender document through https://etenders.gov.in/eprocure/app.

Explanation for Similar works: The work having categorized as specialized in nature, the composite category vendor / contractor is also eligible provided they fulfill prescribed eligibility criteria of the NIT and it is subject to:

1. Supply, installation, testing & commissioning of air-conditioning installations / along with electrical works as a composite type in Government / Semi Government / Public sector organizations.

Or

 OEM / OEA of approved make may associate with the electrical contractor / other agency who fulfill the prescribed eligibility criteria in the NIT for execution of the work with necessary affidavit to confirm their association as per the format of affidavit attached in the tender document.

Or

3. The electrical contractor / vendor who fulfill the prescribed eligibility criteria in the NIT may associate with approved make OEM / OEA for technical support for supply, installation testing & commissioning of air-conditioning system as required with necessary affidavit to confirm their association as per the format of affidavit attached in the tender document.

- **Note:** 1. The successful tenderer/bidder/vendor shall submit written commitment with regards to supply, delivery schedule as per requirement, satisfactory installation & commissioning, unconditional technical support throughout execution of work and comprehensive maintenance contract (if necessary) for the useful life of system after warranty. Also letter of commitment from OEM to provide required spares for healthy functioning of equipment at least for a period of 7 (Seven) years from the date of completion of warranty.
 - 2. The successful tenderer/bidder/vendor is also allowed to change their association with OEM/OEA/contractor during execution with the approval of Engineer incharge.

The estimated cost of work put in the tender will be based on prevailing market rates.
